## What the World Can Learn from India's Approach to Fraud and Inclusion

India operates some of the world's most inclusive, real-time digital systems—spanning payments, credit, mobility, marketplaces, and consumer platforms. At this scale, fraud and abuse evolve quickly: social engineering, mule networks, account takeovers, first-party misuse, and organised rings now cut across **onboarding, transactions, payouts, lending, and collections**, with intervention windows often measured in milliseconds.

### Objective

This **Financial Leadership Roundtable** brings together senior practitioners across fraud, risk, trust & safety, payments, and data to examine how risk is being managed at the perimeter—protecting high-velocity transactions, combating lending and payout abuse, identifying coordinated fraud networks, and using early lifecycle signals to prevent downstream losses and user harm.

A key focus will be the regulatory and operating shift in India, led by the Reserve Bank of India, toward **adaptive, risk-based controls**—and how both fintechs and consumer platforms can translate these principles into stronger trust systems, better data orchestration, and scalable fraud prevention across the entire customer lifecycle.

Hosted by the **Bureau Fraud Forum**, this roundtable is designed as an off-the-record, peer-led discussion that focuses on shared challenges, practical trade-offs, and what global digital ecosystems can learn from India's experience of building trust at scale.
